### *I. WHAT INFORMATION DO WE COLLECT?*

- Upon contribution, we may collect pertinent identifiable information including (but not limited to) your name, birthday, email, address and the like.
- Personal Information may also include information contributors supply to us concerning your preferences and interests expressed including data related to the transactions made to and from your EDCOIN wallet accounts.
- We may also record and collect information shared with our customer support team, or any other information relevant to your use of EDCOIN wallet services.

### *II. WHAT DO WE DO WITH THE INFORMATION WE COLLECT FROM YOU?*

- Any of the information we collect from you may be used in one of the following ways:
  - For enhanced contributor experience
    - ✦ We may use your information for continuous improvement to enhance your EDCOIN wallet experience
  - For EDCOIN services improvement
    - ✦ Any feedbacks or comments you provide will definitely be considered in the betterment of the EDCOIN wallet.
  - For excellent customer service
    - ✦ EDCOIN is geared to always providing unparalleled customer service. Therefore any feedback is greatly welcomed

- For transaction processing
- Any of your public or private information will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever, without your consent, other than for the expressed purpose of delivering the purchased product or service requested.
- To administer a contest, promotion, survey or other site feature.
- To send periodic emails. The email address you provide for order processing, will only be used to send you information and updates pertaining to your order.
  - ✦ Please note that you may opt to unsubscribe to any future newsletters, subscription, solicitations and the like at any time. Details on this process are indicated at the bottom of each email or in the FAQs section.

### III. *INFORMATION SHARING AND DISCLOSURE TO THIRD PARTY MERCHANTS*

Privacy is important to us as it is to you. Therefore EDCOIN fully commits in safeguarding your personal information except in these following circumstances:

- ✦ **MERCHANTS, BUSINESS PARTNERS, SERVICE PROVIDERS, AND OTHERS.** EDCOIN, through the use of EDPOINTS app, provides an avenue for numerous merchants for increased traffic given the nature of the platform. These merchants are third party companies and individuals who are employed by us to facilitate and provide services on our behalf, and to perform application-related services (including but not limited to storage of data, service maintenance, database management, payment processing, web analytics and application and/or site features development and improvement. This means that these third parties have access to your personal information however they are obligated to protect that information and were only given such access to perform the aforementioned tasks on our behalf.
- ✦ **AGGREGATE INFORMATION AND DE-IDENTIFIED INFORMATION.** As part of our demographic profiling, industry analysis and similar objectives, we may share aggregated and de-identified information to third parties however any information shared in these contexts will not contain your personal information.
- ✦ **LAWS AND LAW ENFORCEMENT COMPLIANCE.** Each country and state has its own laws that may compel us to disclose any of your personal information as necessary by law, legal process, litigation and/or requests from public and governmental authorities within or outside your country of residence. Such disclosure will occur in instances of national security threats, law enforcement or other issues of public importance. Also in order to enforce our terms and conditions or protect our operations or users, we may also disclose such information about you as we deem reasonably necessary.
